I am writing to express my opposition to limit participation on girls high school sports teams to "females who were assigned female at birth". I am a white, cisgender woman who has been involved in competitive sports my entire life.

We need to start being more inclusive and accepting of everyone—even if they are different from you. Have you ever been told you are lesser or not worthy or not good enough or too different? I urge everyone to think back to their childhood when life in school was often very difficult. Adolescence is not easy an easy time for anyone. Your body is changing, hormones are raging, you may be teased. We should be finding a way to be inclusive for everyone—not finding more ways to marginalize people. Marginalizing people fosters depression and resentment and sometimes even violence.

Encouraging ALL students to participate in sports is good for everyone. Being a member of a high school sports teams teaches kids about teamwork, and respect for others, and the importance of physical fitness, and achieving personal and team goals. Why would we not want this for everyone?

So please, do not limit participation for transgender girls on girls high school sports teams. Transgender girls ARE girls. Again I urge you to think back to a time when you were marginalized and how it made you feel. It hurt didn't it? Let's include all people.

I coached Middle School Cross Country, Track and Field, and Rifle Team for over 10 years and taught for 27. I was fortunate to coach under a framework that focused on participation and individual growth rather than winning and preparation for athletic scholarships. My first, and only year as assistant coach for the basketball team, parents asked me to take over for the head coach and play only the elite players to preserve their student's chance to be on a winning team with only the best possible teammates. I declined the coup attempt. In part because of its novelty, but mostly because I agree with the philosophy the focus of our coaching is to build good human beings, who play fair and who win and lose gracefully. And to provide those opportunities for as many students as possible. It is in this spirit I implore you to allow middle school students to play on whatever team and in whatever division they feel they belong in. The careers of Chad Bentz, Carlos Boozer and Hilary Lindh would not have been altered much if in middle school, non-binary students were allowed to compete along side them. When Cassie Dunn, wrestled in the boys division for the first time, the possibilities for others expanded as she broke down a barrier that should not be resurrected, and the cost to the boys that she defeated was slight.

As a teacher and coach I struggled to find the desired pronouns and cues to move my students through activities and coaching. Old habits. But my students seemed to accept and respect gender choices and sexual self-identification almost effortlessly. The cost to cis gendered middle school athletes is small in comparison to the costs experienced by gay and lesbian and trans students when participation is denied. If, indeed, we find it necessary to burn this small group of children on the altar of fairness, let us wait until they have the protections that other minorities achieved, through social and political action at that point, banning their participation might make sense. Given the current climate of inflated fears and history of violence against this population we fail as teachers and coaches by forcing this ban on a small group of vulnerable children.

I am writing to you as a biological female who spent her whole high school career playing competitive volleyball against other biological females in the State of Alaska. My plea to you is to protect the next generation of biological female athletes by ensuring competitive fairness and safety by not allowing biological males to participate in biological female high school sports. It is very presumptuous to assume that just because someone supports this idea, that it means they are "trans-phobic" or that they carry mal-intentions towards transgender people. Because I too think everyone should have the opportunity to play sports-- as sports have largely shaped and impacted many areas in my life, especially my work ethic and leadership skills. In addition, to many young girls, sports saves lives by giving purpose and providing a sense of "sisterhood" that they cannot find elsewhere.

However, the reality whether people are in denial or not, is that a biological male's body is built differently than a biological female's body, which gives them advantages in muscle strength, and therefore cannot be fairly matched up in a physical competition. In 2019, Lia Thomas, then competing against males, completed the 1650-yard freestyle in 14:54:76, faster than the female's world-record. Two years later, competing as a transgender female, Thomas broke records by finishing the same event more than 38 seconds ahead of the second-place finisher, a biological female. Thomas also won the 200-yard freestyle with a time of 1:41.93, winning by an enormous margin of nearly seven seconds. Medical journals confirm what is observable to every individual, biological sex is a major factor influencing best performances and results show that females will not run, jump, swim or ride as fast as males. It is empirically certain that males are faster than females and have a significant competitive advantage in sports.

The whole reason there is the distinction between female and male sports is to provide fairness for females who cannot run, jump, swim or ride as fast as a biological male. If the borough allows biological males to compete in biological female sports, the men will end up overtaking the females and there will be no places for the females to compete.

We oppose the proposed regulation that would bar transgender girls from participating on high school girls teams. We are sad and upset that Alaska has been drawn into the transphobia that seems to be sweeping through the states with conservative legislatures and governors. Contrary to the misinformation being distributed to the public by a few lawmakers, (We didn't know we had a problem until Shelly Hughes decided to adopt a page from the national right wing movement and introduced legislation last year.) women's athletics are not under threat or at risk for anything from a small number (only one in 9 years in Alaska according to ASAA Executive Director Mr. Strickland) of transgender kids who want to play. It is a fallacy that you can create a league in which transgender kids can play and I believe you know it. It is discrimination of a class of persons and restricts the participation of those who meet the transgender description. Nationwide, this red herring has become a distracting, wedge issue that rallies conservative groups, particularly right wing religious groups to support policies restricting participation by transgender youth.

Transgender athletes are not "stealing" scholarships from girls. The NCAA already has policies in place on that issue. It is also being presented that those who oppose discrimination directed toward transgender youth are promoting boys playing on girls teams, nothing could be further from the truth and is a misrepresentation to the public of the desire of those who are against discrimination. We oppose the singling out of a class of kids for discriminatory policies.

We have a grave concerns that these policies are just opening the door for future restrictions or laws. I hope you have been paying attention to what is happening in other states such as Florida, Idaho and Kansas to name a few, where laws are now on the book preventing transgender athletes from participating in athletics, and laws making it illegal to provide gender affirming care are being passed. Anti-trans bathroom bills are up for consideration in many states and as you probably know, in the Matsu the anti-trans bathroom issue has already been raised. If you follow through and pass these restrictive regulations, you are probably going to be asked to pass others in the future. We think that making restrictions and discriminations to prevent future incidents is very bad policy.

Our concern extends to how of LBGTQ students may be treated by other students if the state sanctions policies that single out transgender youth. These kids have a higher rate of mental health concerns and to breach their privacy (By the way, privacy is enshrined in the Alaska Constitution.), would contribute to more problems including suicide. It is our opinion and experience that kids who are LBGTQ do not want to attract more attention in high school and virtually no transgender kids have chosen to participate in sports.

The issue is being portrayed as a Title IX issue, we are not convinced it is. Title IX was about providing fairness in funding, facilities, and opportunities for women/girls that men and boys

sports had enjoyed for years. Although there is more equity, there is still a long way to go as evidenced by the treatment of the women's final four by the NCAA a couple years ago. At the high school level in Alaska girls and boys sports are treated fairly equally, but Title IX it is being hijacked by those that say they are trying to protect girls from unfair competition by transgender athletes. Contrary to what some politicians would have us believe, transgender athletes are not overrunning women's sports at any level.

We are not sure that the politicians promoting anti-trans policies and legislation even care about women's sports. This topic is a wedge issue that scores points with their base and provides notoriety for the politicians as culture warriors. Culture wars have been meant to be a distraction from other problems in society such as wealth inequity, suppression of voters rights and corporate corruption. Iowa basketball player Caitlyn Clark probably did more to promote women's sports this season than any politician can hope to do.

I oppose the proposed regulation changes to 4 AAC 06 dealing with school sports.

Excluding transgender and gender diverse children from sports solely based on their assigned sex at birth is a form of discrimination which denies them the same opportunities and rights as their cisgender peers and reinforces a system that perpetuates inequality.

Allowing all students to participate in sports based on their affirmed gender identity ensures equal access and contributes to the creation of an environment where every child can pursue their interests and talents without discrimination. Embracing inclusivity and equality in sports benefits both transgender children and society as a whole.

Further, the proposed regulation changes serve no discernible purpose beyond discrimination, as evidence suggesting that transgender athletes possess “unfair” athletic advantages does not exist. (1)

What evidence does exist, however, shows that exclusionary policies, such as the one proposed currently, do negatively impact transgender people—including children, and that the proliferation of these discriminatory policies not only legitimizes existing biases which impact the health and wellbeing of trans people, but has the potential to further them.

Policies like the one proposed here does the opposite of helping to support the health and safety of children, or students, and student athletes.

Which is why I insist that you do not adopt these changes.

I am a student at UAF and am about to receive my doctorate in geophysics. I have worked with NASA in multiple capacities. I don't like talking about myself. I share that information to point out the fact that I have been very thoroughly trained to understand the reality around me using evidence and logic. I am a former student athlete at the Anchorage School District high school level and collegiate level and a cisgender woman.

These changes are discrimination, hateful, dangerous, and unethical.

It is a myth that allowing trans athletes to compete will harm cisgender women. Trans girls are girls.

Excluding girls who are trans hurts everyone. It invites gender policing that could subject anyone, trans or cisgender to invasive, discriminatory, and harmful tests or accusations of being “too masculine” or “too good” at their sport to be a “real” woman. This is divisive, stigmatizing, and creates truly deadly risks.

Meanwhile Trans athletes vary in athletic ability just like cisgender athletes do and this is often due to reasons far beyond biological sex assigned at birth. For example, consider factors like wealthy parents who spend thousands on a child’s personal training for a sport outside of school.

There is literally no evidence to prove that the very same cis girls who have claimed that trans athletes have an “unfair” advantage do not already consistently performed as well as or better than transgender competitors.

As a student athlete both as a varsity girls flag football player and a player on the University of Oregon’s women’s rugby team, it has been an honor to compete alongside my fellow teammates and opponents, both trans non-binary and cisgender and the true threats I have felt as a student athlete have come from lack of funding for women’s sports and anti-lgbtq discourse such as this that has hurt the people I love, the family that I found on sports teams.

Trans women are women and every woman and girl has the right to participate in sports and play as well as to privacy. Shame on you for considering this at all and for subjecting trans youth and the LGBTQ community to the vitriolic, dehumanizing discourse that this proposal creates, particularly after Alaska’s citizenry overwhelmingly rejected this idea on multiple occasions in the state legislature.

I am a mom for four awesome girls, coach leading 60 plus youth girls in basketball each week, and past athlete who was blessed to play sports growing up. I am deeply troubled by the idea that the state may open female sports up to boys who have made a decision to be considered female. While I support and will love all people, allowing biological boys to play girls sports will set girls back to pre Title IX days. I grew up taking pride in the fact that I could compete with and against amazing girls on the court and in the field. I worked so hard to be the best I could be and gained a ton of confidence along the way. I want the same opportunities for my daughters and all the youth girls that choose to be athletes as well. I am writing in support of the proposed changes to inter scholastic activities supporting girls sports. I'm a concerned parent of three children who all attend public school here in Alaska. There are many reasons that girls should be able to compete against only other girls who were born female. First is safety because the male body is physically stronger than females. Even if a person is transitioning it takes years for their body to change when taking hormones. In high school their body will still be stronger than a female. If girls are playing against trans athletes in basketball, soccer, volleyball, etc. they are more likely to be injured. Which has happened already.

Second boys have bigger hearts and lungs than girls which gives them an advantage when competing. They have more red blood cells which carry oxygen to muscles. Women have a higher fat percentage which means they're carrying extra weight. Third I'm concerned my girls and others could lose out on scholarships, a place on the team, and losing their self confidence because they aren't able to defeat a trans athlete in individual sports such as wrestling, track and field, cross country running, swimming and gymnastics.

Lastly girls should not have to share locker rooms with trans athletes. Dear Ms. Andrews and Board Members:

I write in support of the proposed amendments to 4 AAC 06.115(b)(5) to protect girls' sports and respectfully request the Board of Education to adopt the regulation with the minor amendment discussed here.

As you are no doubt aware, 4 AAC 06.115 is the regulation governing interscholastic competitions. Paragraph(b) of the regulation permits a school or school district to pay dues to the the Alaska School Activities Association, Inc., or other similar nonprofit associations administering interscholastic activities in Alaska. In each case, the school or school district may pay dues only if that association administers interscholastic activities in a manner consistent with good sportsmanship and academic rigor. Paragraph(b)(5)(d) as amended will now require that to meet those standards, the associations must administer interscholastic activities in a manner that:

ensures fairness, safety, and equal opportunity for female students in high school athletics by providing... that if a separate high school athletics team is established for female students, participation shall be limited to females who were assigned female at birth...

The proposed regulation recognizes a biological reality best exhibited by girls and boys competing in the quintessentially Alaskan Mount Marathon competition this past Fourth of July. If not divided by biological sex, the winning girl would have come in 14th in the race, behind thirteen boys. The second-place girl would have been 25th; the third-place girl would have been 38th; the fourth-place girl would have been 43rd; ad the 5th place girl would have placed forty-fourth. The tenth-place girl, still a mark of high achievement in such a grueling competition, would have placed 51st, a 5x difference in her actual accomplishment.


The biological reasons for protecting female-only sports competition are readily apparent. Biological sex is binary, determined by genetic code at conception, not choice. On average, boys become stronger than teenage girls by the age of thirteen. They are stronger than grown women by the age of fourteen. The body strength of teenage girls is roughly 67% that of teenage boys. Enhanced physical capability in boys is a result not only of higher testosterone levels, but of larger hearts, larger lungs, larger throats, and longer bones. As such, to compete on their own merit and under fair rules of competition, female athletes should compete against their biological peers.

This is not about lack of empathy for individuals who seemingly believe they can change their biological sex. I do want a place for these children to heal and athletics may be part of that journey. However, that healing should not be at the expense of young girls, such as my own. My daughter competes in both volleyball and softball at a local Anchorage high school. As the proposed regulation states, she deserves a guarantee of fairness, safety, and equal opportunity, especially when it comes to using athletics to find her place in the world.

Although I fully support the regulation, I do request one amendment. The proposed regulations utilize “females who were assigned female at birth” to explain who these athletes entitled to compete against their own peers are. However, even those words create unnecessary confusion. Sex is not assigned at birth when health care providers look at physical characteristics of an infant. It is a biological reality determined by chromosomes at the time of conception. As such, I recommend the Board utilize the term “biological females” in place of “females who were assigned female at birth” when describing the protected class.

Thank you for the opportunity to provide public comment on this extremely important regulatory change. I look forward to its final implementation into the laws of Alaska and the long-term protection of female sports and young girls going forward.

In regard to the "Resolution to Preserve Opportunity for Student Athletes While Balancing Competitive Fairness, Inclusion, and Safety for All Who Compete," I support the part of the amending subparagraph to 4AAC 06.115(b)(5) which says:

"(D) ensures fairness, safety, and equal opportunity in athletics by providing, in consideration of responses to a school survey under 4 AAC 06.520,

(i) a separate team for each sex with participation based on a student's sex assigned at birth;

(ii) a team for students of either sex regardless of sex assigned at birth;"

Generally speaking males are stronger, bigger and faster than females. When biological males are allowed to compete with biological females they have a distinct advantage. They are likely to win trophies and get athletic scholarships that would otherwise go to biological females who have often worked for years to be competitive. This is unfair to individual biological females and to women's sports.

There is also the chance of injury to female competitors as was the case of the high school volleyball player, Payton McNabb, who was seriously injured when a male player forcefully hit a ball into her face.

I do not support (D)(iii) which provides for a separate team for female students with participation based on a student's sex assigned at birth and a team for students of either sex regardless of sex assigned at birth, but does not provide for a separate team for male students with participation based on a student's sex assigned at birth.

In a state where domestic violence and sexual assault are significant issues it is problematic that we would encourage biological males to engage with females in competitive sports, especially contact sports. As parents most of us teach our children to respect the opposite sex. To then say for instance "except if you're a male and want to wrestle with a female and overpower her with sheer strength, or play a sport like football and tackle a female full force as you would a male." It is unfair to the males, if they have been taught all their lives to respect and protect women. In contact sports they are less likely to play with the force they would use with a male competitor. Therefore they will be less likely to win. It is unfair to the females because there is greater chance of injury. Granted, many injuries are accidental, but they can be just as painful and debilitating as intentional injuries.

An exception would be competitions such as mixed doubles in tennis or coed team sports such as baseball or volleyball where there are an equal number of males and females on each team, and every player agrees to having both sexes play.

Additionally, it opens the door for biological females to play on male teams and risk a greater chance of injury. Although most biological females would not choose to try out for a male team, it is foreseeable that some might do that.

Therefore, I support subparagraph (D)(i) and (ii), but not (iii).

My name is Didi Peters. I live in on the Kenai Peninsula and I am a graduate of Kenai Central High School.

Please don't segregate cis and trans girls in athletics. I can think of many reasons it is an unnecessary step. For instance, the schools don't have the resources available for a new, third coed division. There won't be enough students to fill the team rosters, leading to forfeits and cancellations. There's not enough time at the school's facilities for practices, nor playing-field space available for games in the evenings and weekends. We'll need more adults to officiate. It's all going to cost money at a time when the existing, inclusive, competitions are working! I think this separate division will be unequal and lead to violations of the participating students' rights. These inequities will lead to less safe sports for trans girls and they could be injured at higher rates than they are currently.

Now is a time when civil rights for transgender people, of all ages, are being taken away. It seems to unify the members of the Republican Party. Seeing them all dance to this tune induces my anxiety, and I would guess children aren't unaware of this anti-trans movement sweeping across their country. Think of the consequences of that worry on children's mental health; surely it is detrimental to their learning. You're entrusted with protecting all kids, including the LGBTQ ones. The following is my 3 minute testimony in support of the DEED Resolution.
I follow my verbal with additional
written information.

My name is Mike Coons from Palmer Alaska. I fully support the DEED Regulation on Interscholastic Activities. This has nothing to do with any discrimination towards any of the approximately 7.2%, nationally who identify as LGBCD, of those, 0.3% are CD. For Alaska, 350, 13-17 year old's identify as cross dressers, 5,000 total LGB. For the record I refuse to use the word "Transgender" since that is a lie and I will not use their language in furtherance of that lie.

This is about the safety of girls and women whom participate in sports from harms caused by going up against a boy or man whom has far better physical capabilities.

As we have seen, in the case of college swimming, a male could not compete at the highest levels with his fellow male athletes. He decided to say he was a woman, was allowed to compete with those women and because he had more muscle mass, greater lung capacity, etc. stole competitions away from those women athletes. Just on FOX on 19 April was a volleyball female athlete who stated that males competing in the female division now have a net 7 inches lower than male volleyball, which causes a dramatic unfair advantage. Even more recently, Connecticut is being sued by a female track athlete who is the fastest girl in her sport, but because a boy beat her, she lost out on valuable College Scholarships. I would not be surprised on how having to have a male in the female locker-rooms prior to an event, especially in an individual sport has a mental impact on the upcoming competition. Having to see a naked man undressing, dressing for an event must be mentally tasking and disturbing to say the least. This time is when the athletes are getting their heads into the upcoming event. This adds another layer of disadvantage to women.

You have heard a lot today that has nothing to do with this regulation.

That this will increase suicides of cross-dressers, yet crickets on girls suicide increases. Not said is there is an even higher suicide rate of cross-dressers post surgery and hormonal therapy. You have heard anger, high emotions and threats of lawsuits, threats of violence, make no mistake, violence will come. This is how this group acts, through verbal and physical intimidation. We have the White House, without Congressional action, wanting to change Title IX and then withholding education funding if we refuse to follow his dictates. Not only does that violate the 10th Amendment, but he is being a dictator. All parents want is what is best for their child not just in sports but throughout life. Stand your ground for all children of Alaska by disregarding these vial attempts and standing for the 99.07% of normal Alaskans!
BTW Matsu School Board rocks and is leading the way on this and many other issues!

That concludes my verbal testimony. I would like to add in my written testimony some supporting comments for the verbal testimony and other comments I did not have within the time limits.

I support that regulations should

1. Provide a girls' division with participation based on a student's biological sex at birth.
2. Provide a division for students who identify with either sex or gender.

This is fair and reasonable so all can participate in the sport of ones choosing. If any harms happen, because of size differences, then that was already agreed to by the parents and players.

The board will be told by those supporting males on females' team that as board members they will be responsible for increased depression and suicide for those with gender dysphoria if they set a policy based on biological sex. The advocates will try hard to lay future blame on them.

The truth is that depression rates and suicide ideation are already troubling among these youth, absent the sports issue. It is access to real mental health services, not the so called mental health from people whom advocate for this dysphoria as "normal", the care and support by loving families and friends that will help these young people. These children need to be affirmed as whom they really are as a boy or girl, know they are valued, know they are accepted and loved and that the affirmation, love and help is there to move them forward as adults not some policy that is discriminatory against girls and women which causes more frustration, division, anger and confusion. The truth is that depression rates and suicide ideation are also trending alarmingly upward among teenage girls.

Trying to address mental health issues for a small group of confused youth through a policy that is unfair and unsafe for girls not only does not solve the depression and suicide issue for that small group but it exacerbates the depression and suicide problem for the entire teenage female group while also creating unfair and unsafe conditions for girls which rob them of opportunities. Trying to fix one problem by creating another is clearly not the answer, especially when the attempt won't work anyway. As I stated in my verbal testimony, please understand these tactics are used because the advocates who are pushing for male access to girls' teams don't have a logical basis for their argument; the data doesn't support their position. Shaming and canceling will be their MO and the Education Board members need to be prepared for it, recognize it when it happens, and resist it. I and many others ask the Education Board to do the right thing in a respectful and civil manner, with kindness and gratitude for your service and with applause for your commitment to ensure girls do not face discrimination but retain an equal opportunity to participate and excel in sports. Let's not forget that the policy you will be setting will have ramifications as far as protecting girls' dignity and privacy in the locker room, the showers, and the bathrooms while participating in sports, not to mention for sleeping arrangements when teams travel for away-games.

Thank you for your time, effort and sacrifices as board members. I was a commissioner for the Alaska Commission on Aging and am very aware of your sacrifices.

Board of Education-

I am a mother of four including one daughter, a health care worker, a lifelong athlete and college lacrosse player, a local school board member and an Alaskan resident.

I am writing to urge you to protect biological girls' sports. We are all aware of the biological and physiological differences between males and females and while they exponentially grow after puberty they are present from birth. We are all also aware of the horrific injuries that have occurred against biological females in sports in the last two years. The female volleyball player with a broken neck that lost scholarships because a male spiked the volleyball to her head.
